Therefore, in order to prevent conflict between personal interests and public interests (Conflict of Interest) Receiving bribes, gifts, gifts, or any other benefits that affect the performance of duties at the police station. Provincial Lansaka Therefore, guidelines for anti-bribery practices have been established. (Anti-Bribery Policy) and do not accept gifts, presents or any other benefits (No Gift Policy) from performing duties. with details as follows:

objective

๑. To prevent or reduce the opportunity to receive bribes. Conflicts of interest in various forms police officer Under the jurisdiction of Lansaka Provincial Police Station
๒. To encourage police officers Under the jurisdiction of Lansaka Provincial Police Station Have awareness in Refusal to accept gifts and gifts of any kind in the performance of duties.

၈. To create an ethical and transparent organizational culture. (Organization of Integrity) of the system government to be strong and sustainable

၉. To determine measures, guidelines, and mechanisms to prevent giving/receiving bribes or benefits. Anything else

၉. To determine guidelines for receiving compensation, entertainment, or gifts by executives and police officials in Under Lansaka Provincial Police Station To comply with relevant laws and regulations.

၁၀. To support and enhance operations under the national strategy, master plan under national strategy and the national reform plan for preventing and suppressing corruption and misconduct. It is also part of the guidelines for evaluating morality and transparency in government agencies (ITA).

Scope of application

Applicable to police officers under the jurisdiction Lansaka Provincial Police Station, all officers

Definition

“Bribe” means property or other benefits given to a person to enable that person to do or refrain from doing anything in your position. Whether the action is legal or illegal according to the person who paid the bribe need

“Gifts, presents, or any other benefits that affect the performance of duties” means money. Property, services, or other benefits that are of value and are provided, including tips. which government officials received in addition to Salary, income, government benefits in normal cases and affecting decisions, approvals, permissions, or in the performance of duties in a manner that is beneficial in a dishonest way to the gift giver in the past or at the time of receipt or in the future

“Property” means property and intangible objects. which may have a price and may be held such as money, houses, cars, stocks

“Receiving property or any other benefits in an ethical manner” means receiving property or any other benefits from relatives or people given on various occasions, usually according to customs, traditions, or culture or giving to each other according to the etiquette practiced in society

“Relatives” means parents, descendants, brothers and sisters. or joint father or mother same person, uncle, aunt, spouse, parent or descendant of the spouse Adopted child or adoptee

“Other benefits” means things of value, such as price reductions, entertainment, Services Receiving training or anything else of the same nature

“Performing duties” means the actions or performance of duties of a government official.in the appointed position or has been assigned to perform any duties or to act instead in any duty, both general and specific as a police officer, as determined by law. Powers and duties or act in accordance with the powers and duties specified by law to be the powers and duties of the police.

Guidelines for preventing bribery

၁. Prohibited police officers under the Lansaka Provincial Police Station get involved in giving or receiving any form of bribe, whether direct or indirect.

၂. Police officers under Lansaka Provincial Police Station are prohibited from requesting or receiving Bribes for personal gain or the benefit of another person

၃. Follow the anti-corruption policy. without getting involved with Corruption: Corruption, whether direct or indirect.

၄. The performance of duties must be carried out in accordance with regulations, police discipline and laws. strictly related

၅. Do not do anything that is considered giving or receiving a bribe.

၆. Supervise the disbursement of expenses of affiliated agencies in accordance with the law. Strictly related regulations

၇. Receiving donations or financial support Whether it's money object or property to the activity or any project must strictly comply with rules, regulations, and announcements. and have a receipt or evidence of Receive money Report every time

၈. Receiving property or any other benefits by ethics, police officers under the station Lansaka Provincial Police Every officer must abide by the announcement. Anti-Corruption Commission National Regulations on the Criteria for Receiving Property or Other Benefits by Ethics of Officials, B.E. ၂၀၁၆ strictly

Punishment measures/violation of guidelines

၁. Violation of not following this policy. May be subject to disciplinary action or prosecute a criminal case; or Other related laws Including direct supervisors who ignore wrongdoing. or acknowledge that there has been an action Wrong but did not proceed with management correctly which has disciplinary punishment to the point where Dismissed from government service

๒. Failure to be aware of this policy announcement and/or related laws cannot be used as An excuse for not complying is allowed.

๓. Supervisors according to the Police Department Order No. ๑๒๑๒/๑๙๙๔ dated ๑ October ๑๙๙๔ have the authority The duty is to supervise and supervise subordinates under supervision to strictly adhere to and comply with this policy.

Monitoring measures

๑. Superintendent of Lansaka Provincial Police Station Declaration of intent to manage the agency Honestly, transparently and in accordance with the principles of good governance. By publishing public relations to government officials. Police under the jurisdiction and external stakeholders know.

๒. To the commander according to the Police Department Order No. ๑๒๑๒/๑๙๙๔ dated October ๑, ๑๙๙๔, Powers and duties to supervise, monitor, and inspect police officers who are under their control. Behave according to this announcement. In the event that an action that violates this announcement is found Report to the superintendent Lansaka Provincial Police Station will be informed immediately.

๓. Lansaka Provincial Police Station will arrange an inspection. Evaluate compliance results This practice is done every year. and arrange for review and improvement of compliance guidelines as appropriate or at least once a year or according to changes in various factors that are significant

๔. Give the administration department Lansaka Provincial Police Station provides statistics on receiving gifts or gifts. What other benefits? along with problems, obstacles, and solutions and report to the Superintendent of Lansaka Provincial Police Station. Know every quarter

Measures to protect complainants/whistleblowers Confidentiality Measures to protect petitioners and witnesses

๑. Consideration of complaints Set the level of secrecy and protect those involved according to the regulations. by maintaining government secrets, ๒๐๐๑, and submitting matters to the agency for consideration. information provider and the complainant may suffer, for

example, complaints against government officials will initially be considered It's a secret way. government service, if it's an interesting card Consider only the cases with specified evidence. The surrounding circumstances are clearly evident and pointed out. Only natural witnesses

Reporting information on influential people must conceal the name and address of the complainant. If the name and address of the complainant are not concealed Must notify relevant agencies and provide protection to the complainant as follows: "Let the commander use his discretion to give orders.as appropriate to protect the complainant, witnesses, and persons providing information in the investigation Don't let yourself suffer danger or suffering. Unfairness that may arise from complaints Being a witness or giving that information."In the case where the name of the correct person is specified Allegation must protect both the complainant and the respondent because the matter has not yet gone through the fact-finding process. and may be a form of bullying, alleging suffering and damage, and in the case the complainant specifies in the complaint Request concealment or do not wish the complainant's name to be disclosed. The agency must not reveal the name of the complainant to the agency. The respondent. Known because the complainant may have suffered as a result of the complaint.

၇. When there is a complaint The complainant and witnesses will not be subject to any action that affects their work. or livelihood If any action is necessary, such as separating the workplace to prevent the complainant Witnesses and the accused meet together, etc. Consent must be obtained from the complainant and the witness.

၈. Requests from the injured party, the complainant, or witnesses, such as a request to move a place of work. or method in Preventing or solving problems Should be considered by responsible persons or agencies as appropriate.

၉. Provide protection to the complainant from being harassed.


Measures to protect the accused

၁၀. During the consideration of the complaint, the accused is not yet considered guilty. must be Dharma and to be treated the same as other people

၁၁. Give the accused an opportunity to fully explain the allegations. Including the right to perform Documents/evidence
